- > Based on the evidence by the teacher, parent and multiple assessment
- Using the screening data (WaKIDS, DIBELS), the classroom teacher and Highly Capable Team will identify the students that will:
 - o Are nominated administered by classroom teacher
 - o Parent Check Sheet
